

INVITATION TO BID FOR

I.T. Supplies

(Name of Project)

- The CITY GOVERNMENT OF ZAMBOANGA, through the General Fund intends to apply the sum of ONE MILLION FIVE HUNDRED EIGHTY EIGHT THOUSAND TWO HUNDRED FIFTEEN PESOS & 60/100 (P1,588,215.60) ONLY being the Approved Budget for the Contract (ABC) to payments under the contract I.T. Supplies (PR No. 100-19-06-1654). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The City Government of Zamboanga now invites bids for 40 pcs. Flash Drive, 16GB, USB 2.0, plug and play, 201 carts Ink Cart, Epson C13T664300 (T6643), Magenta, etc. Delivery of the GOODS is required for <u>Ten (10) Calendar Days</u>. Bidders should have completed within a period of ten (10) years from the date of submission and receipt of bids, a contract similar to the Project, with a value of at least (50%) of the ABC and to meet other eligibility requirements stated in the Eligibility Documents. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested Bidders may obtain further information from City Government of Zamboanga in the Office of the City Mayor-Procurement, Acquisition and Awards Division (PAAD) and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on <u>August 07, 2019 to August 27, 2019</u> from the address below and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest guidelines issued by the GPPB, in the amount of <u>P1,588.22</u>. The method of payment will be Cash payable to the City Treasurer's Office. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.
- 6. The City Government of Zamboanga will hold a Pre-bid Conference on <u>August 15, 2019 at 10:00 AM</u> at City Mayors Procurement, Acquisition and Awards Division, Conference Room Villalobos St., Z.C. which shall be open to prospective bidders.
- Bids must be duly received by the BAC Secretariat at the address below on or before <u>August 27, 2019 at 10:00 AM</u>. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
 Bid opening shall be on <u>August 27, 2019 at 10:00 AM</u> at City Mayor's Procurement, Acquisition & Awards Division, Conference Room Villalobos Street Zamboanga City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a Bid Security which shall be a Bid Securing Declaration or at least one other form of the following: cash, cashier's /manager's check, bank draft/guarantee confirmed by a Universal/Commercial Bank, Irrevocable Letter of Credit issued by a Universal/Commercial Bank or from other bank certified by the Bangko Sentral ng Pilipinas as authorized to issue such financial instrument, provided however that it shall be confirmed or authenticated by a Universal/Commercial Bank if issued by a foreign bank in the amount of P31,764.31 or Surety Bond callable upon demand issued by a Surety or Insurance Company duly certified by the Insurance Commission as authorized to issue such security in the amount of P79,410.78 or any combination of the foregoing in the amount proportionate to share of form with respect to total amount of security.

The Bid Security shall be denominated in Philippine Pesos and posted in favor of the Procuring Entity.
