Concreting of Road at Alfaro Drive, Tetuan

Name of Project

Concreting of Road which involves project billboard/signage, temporary facility, safety & health, mobilization and demobilization, barricades, sub-grade preparation, aggregate subbase course and portland cement concrete pavement.
(Brief Description)

1. The CITY GOVERNMENT OF ZAMBOANGA, through the **GENERAL FUND (AB FY- 2016)** intends to apply for Re-Bid the sum of **EIGHT HUNDRED THOUSAND PESOS (P800,000.00) ONLY** being the Approved Budget for the Contract (ABC) to payments under the contract for **Concreting of Road at Alfaro Drive, Tetuan**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. Bidding will be conducted through negotiated procurement, per **Resolution No. AMP-19-010 dated March 25, 2019** pursuant to *Section 53.9 "Small Value Procurement"* specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
3. Bid opening shall be on **April 11, 2019 at 10:00AM** at Office of the City Mayor- Procurement, Acquisition and Award Division (PAAD) Conference Room, Villalobos Street, Zamboanga City. Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.
4. A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **P1,000.00**.
5. The required completion of the works is **Sixty One [61]** calendar days.
 - A. **Equipment to be used:** Prime Mover, Road Grader, Road Roller, Water Truck, Bagger Mixer, Concrete Vibrator, Concrete Cutter, Water Truck, Bar Cutter and Dumptruck.
 - B. **Key Personnel:** Project Manager, Project Engineer, Material Testing Engineer, Construction Safety Officer and Foreman.

The City Government of Zamboanga reserves the right to accept or reject any Bid, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
