- The CITY GOVERNMENT OF ZAMBOANGA, through the GENERAL FUND (SB# 01 FY- 2018/AB FY- 2018) intends to apply for the sum of SIXTEEN MILLION EIGHT HUNDRED SEVENTY THOUSAND PESOS (P16,870,000.00) ONLY being the Approved Budget for the Contract (ABC) to payments under the contract for Construction of Two (2) Storey Eight (8) Classroom School Building at Lunzuran Elementary School, Lunzuran (Revised). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The CITY GOVERNMENT OF ZAMBOANGA now invites bids for Construction of School Building which involves demolition works, project billboard/signage, safety & health, temporary facility, A. School Building Layout and excavation,embankment (loose volume), soil poisoning and termite control, reinforcing steel bars, structural concrete, masonry works, carpentry works, steel works, roofing works, light steel framing system, doors, windows, window grilles and louvers, electrical works, plumbing works, tile works, concrete masonry unit, railings and mobilization/demobilization. Completion of the Works is required in Three Hundred Fifty
 Six [356] calendar days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project, equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
