



INVITATION TO BID FOR

Zamboanga City Waterfront and Heritage Walk Development

(Name of Project)

1. The CITY GOVERNMENT OF ZAMBOANGA, through the **TRUST FUND** intends to apply for the sum of **SEVENTY FOUR MILLION ONE HUNDRED ONE THOUSAND ONE HUNDRED EIGHTEEN PESOS (P74,101,118.00) ONLY** being the Approved Budget for the Contract (ABC) to payments under the contract for **Zamboanga City Waterfront and Heritage Walk Development**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The CITY GOVERNMENT OF ZAMBOANGA now invites bids for *Zamboanga City Waterfront and Heritage Walk Development which involves project billboard/signage, safety & health, temporary facility, barricades; A. Boulevard; Irrigation Works, Plant Box (Along Sea Side, Center and Along Road, layout and excavation, reinforcing steel bar, structural concrete, masonry works, finishes, softscape, concrete bollard, concrete encasement and concrete pedestal column, electrical works, stamp concrete, Extension area, viewing deck, speed table and cross walk; embankment, finishes, stainless steel railing, Land Mark; layout and excavation, embankment, reinforcing steel bar, structural concrete, finishes, stamp concrete, fiber glass signages, speed table and cross walk, B. Heritage walk, homogenous tiles, softscape, Side Walk Expansion; chipping works, reinforcing steel bar, structural concrete, irrigation works, Bench, Flush planting strip and metal grating, speed table and cross walk, layout and excavation, reinforcing steel bar, structural concrete, wooden seat, metal grating and speed table and cross walk.* Completion of the Works is required in **Two Hundred Six [206]** calendar days. Bidders should have completed, within ten (10) years from the date of submission and receipt of bids, a contract similar to the Project, equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
4. Interested Bidders may obtain further information from the Office of the City Mayor-Procurement, Acquisition and Award Division (PAAD) and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM starting **August 02, 2019 to August 21, 2019**.
5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **P74,000.00**.
It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.
6. The City Government of Zamboanga will hold a Pre-Bid Conference on **August 09, 2019 at 10:00AM** at the Office of the City Mayor-Procurement, Acquisition and Award Division (PAAD) Conference Room, Villalobos Street, Zamboanga City, which shall be open only to all interested parties who have purchased the Bidding Documents.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **August 21, 2019 at 10:00AM** at Office of the City Mayor-Procurement, Acquisition and Award Division (PAAD) Conference Room, Villalobos Street, Zamboanga City. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
Bid opening shall be on **August 21, 2019 at 10:00AM** at Office of the City Mayor- Procurement, Acquisition and Award Division (PAAD) Conference Room, Villalobos Street, Zamboanga City. Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below. Late bids shall not be accepted.
8. Bidders are required to indicate the validity period of their bids in the Bid Form. Failure to indicate the same shall be considered that the bid is valid for a period of 120 calendar days as specified in Section 28.1 of the Revised Implementing Rules and Regulations of R.A. No. 9184.
All bids must be accompanied by a bid security which shall be a **Bid Securing Declaration** or at least one other form of the following: cash, cashier's /manager's check, bank draft/guarantee confirmed by a Universal/Commercial Bank, Irrevocable Letter of Credit issued by a Universal/Commercial Bank or from other bank certified by the Bangko Sentral ng Pilipinas as authorized to issue such financial instrument, provided however that it shall be confirmed or authenticated by a Universal/Commercial Bank if issued by a foreign bank in the amount of **P1,482,022.36** or Surety Bond callable upon demand issued by a Surety or Insurance Company duly certified by the Insurance Commission as authorized to issue such security in the amount of **P3,705,055.90** or any combination of the foregoing in the amount proportionate to share of form with respect to total amount of security.

39.1	The amount of the advance payment is <i>Fifteen (15%) percent of the Contract Price as mobilization cost.</i>
40.1	Materials and equipment delivered on the site but not completely put in place shall be included for payment.
51.1	The date by which operating and maintenance manuals are required is <i>upon completion.</i> The date by which “as built” drawings are required is <i>upon completion.</i>
51.2	The amount to be withheld for failing to produce “as built” drawings and/or operating and maintenance manuals by the date required is <i>[amount in local currency]</i> .
